#### Experience

He has served in county counsel offices for over 26 years. Most recently, he served as interim county counsel for Mendocino County while they recruited for and selected a new County Counsel. In 2023, Jim was recognized for his outstanding service by the County Counsel Association of California. During his career, Jim served as county counsel, assistant county counsel and deputy county counsel. Prior to years of working with counties, Jim served as a city attorney and a deputy city attorney as well as providing legal advice to special districts. During his career, Jim has advised governing bodies and departments on the full range of legal issues faced by local government agencies.

Jim's practice focuses on advising public agencies in multiple areas of public law including general government agency advice, affirmative litigation, land use, public works, elections and litigation oversight and management. Jim has advised the Code Enforcement Division of the Sonoma County Permit & Resource Management Department and represented the Public Conservator/Guardian. In Sonoma County, he also advised on the formation of a Geological Hazard Abatement District which included a FEMA property acquisition program for landslide affected properties.

Jim began his career as an associate of McDonough, Holland & Allen where he served as the Marysville city attorney and served as a deputy city attorney for other cities including the City of Davis. During this time, he advised several special districts and other local entities. Jim was part of the trial team that successfully defended the City of Roseville against claims for damages including inverse condemnation claims arising out of historic flooding. Jim also co-authored the Amicus Curie brief in the case *Lockin v. City of Lafayette* (1994) 7 Cal.4th 327.
